The Renewable Fuels Association has issued a carefully worded advertisement, omitting or mischaracterizing critical details about the fuel market and the Renewable Fuel Standard (RFS), as well as about the Small Refinery Exemptions (SRE) designed by Congress as a required component of the RFS. AFPM's fact check sheds light on several key details the RFA ad got wrong:

Congress explicitly wrote this into the statute and only Congress can change it

Hardly a "regulatory barrier"

President Trump recently removed an outdated regulatory barrier to allow E15 to be sold year-round—a move expected to expand the domestic market for ethanol by about 50 million gallons over the next year.

Unfortunately, that modest demand growth is a drop in the bucket compared to the billions of gallons lost to exemptions given to 35 refineries from their renewable fuel blending obligations.

U.S. Energy Information Administration data shows the small refinery exemptions, which the law requires, have had NO impact on ethanol blending. Blend rates increased in 2016, 2017 & 2018 — and are on-track to do so in 2019.

CONGRESS SPECIFICALLY DESIGNED SMALL REFINERY EXEMPTIONS IN RFS

This undermines the RFS, a law policymakers from BOTH sides of the aisle support because it: **oppose**

- 1 keeps prices down by 22¢ a gallon for consumers
- 2 reduces harmful tailpipe and greenhouse gas emissions
- 3 increases America's energy security

- 1 Adding billions of dollars in compliance costs does not help keep prices in check
- 2 EPA's own study concludes RFS is a wash for the environment — at best
- 3 imported biodiesel needed to fulfill mandate — NOT helping!

Americans need to stand up for fuels that are better for its wallet AND the environment.
